Thank you for your membership, which helps to fund the vital work that we do on behalf of all UK consumers through our research, campaigning and advice. What is the role of a trustee and how long is their term?

Trustees govern the Consumers'
Association (the charity). They are recruited with the aim of creating a Council with a diverse range of backgrounds, skills and experience which can promote UK consumer interests and ensure the charity continues to deliver its valuable work for the long-term. The Council is responsible for setting the strategy for the charity and its group. It also monitors and scrutinises delivery to ensure the charity's success in making consumers' lives simpler, fairer and safer.

Trustees are appointed for an initial term of around three years. Appointees are subject to approval of voting members at the first AGM following their appointment. Trustees may ordinarily serve up to a further two three-year terms, running from AGM to AGM. All reappointments are subject to member approval.

How are trustees reappointed?

Our Nominations Committee considers and makes recommendations to Council on the reappointment of any trustee reaching the end of a three-year term. If a trustee is eligible to serve for a further term, their skills and experience in relation to the Council's needs are considered, along with their ability to commit time to the role, before a recommendation is made.

For new trustee appointments, the Nominations Committee leads an extensive search and selection process, which focuses on the skills and experience required on the Council, and takes account of the governing bodies equity, diversity and inclusion strategy adopted in September 2024. More than half of the Nominations Committee's members are trustees. The others are two independent members who have recruitment experience and the Chair of the Board of the Charity's subsidiary.

Council makes a decision whether to appoint and reappoint trustees based on the Nominations Committee's recommendations, which is then subject to approval by voting members.² You can learn more about our appointment process and all of our existing trustees on our website:

Voting instructions

The Council of Trustees (the Council) recommends that you vote in favour of:

- . the appointment of Justine Shaw
- . the reappointment of Adam Shutkever
- . the reappointment of Richard Sibbick
- the reappointment of Charles Wander

For avoidance of doubt, you are being asked to vote on the appointment or reappointment of **all** the trustees recommended by Council, not to choose between them.

This year all votes will be cast live at the Annual General Meeting on 29 November 2025 rather than in advance. By voting, you will be appointing the Chair as your proxy holder to cast your vote live at the meeting.

You can direct the Chair to vote in a certain way on the Proxy Form, either through the online voting website or by phone. The voting website link and phone number are provided below.

If you do not indicate how you want the Chair to vote, the Chair will cast your vote in line with the Council's recommendations.

Our voting arrangements are managed independently by Civica Election Services. Civica operates the Voting Platform and telephone service.
